

CD- 405 - C Corporation Tax Return

NOTE: The fiscal year beginning date must have “09” hard coded for the tax year. This part of the fiscal year should be hard coded to prohibit other tax years from being entered on the form.

Changes for the Year:

Tax year updated. Line reference changes and “Nonprofit/Tax Exempt” added at the top of the form.

Requirements:

Special Requirements

If Federal Schedule M-3 is required for federal purposes, print Federal Schedule M-3 for the NC return and place an "X" in the "Fed Schedule M-3 attached" box on this form (Print Line Number 16, Field Description, M3).

Barcode

The barcode number on the first page must read 63001xx011. Replace (xx) with your two-digit Software Developer Identification Number.

Placement on first page: Align between Row 26, Column 6 - 10 and Row 41, Column 6 - 10. The start character in the barcode will begin on Row 26. The barcode will end on Row 41. Print the number either stacked or vertically to the right of the barcode.
