

2006 Partnership Tax Credit Summary

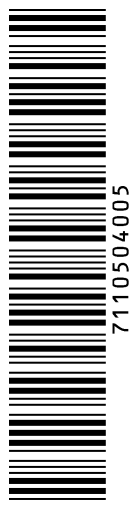
