General Instructions

Use this form to report to the Department of Revenue the gross receipts from the resale of admission tickets on the Internet. The law, in G.S. 14-344.1, requires the reseller to file a monthly report with the Department listing the gross receipts from reselling tickets and other specified information. If you have questions about how to complete this form, please call the Department's Policy Analysis and Statistics Division at 919-733-4548.

Submit only one copy of the front page of Form TR-110. Part 1 contains the summary information for entries in Part 3. Additional pages of Part 3 may be submitted and Part 1 should contain the summary for **all** entries in Part 3.

Part 3: In column A, enter the event name and the venue for each event for which tickets were resold. In Column B, enter the name of the person or the venue from which tickets were purchased. Column D is the total amount of money that was paid for the tickets. Column E is the total amount received from the sale of tickets. Column F is the total gross receipts: the amount received from the sale of tickets less the sum of the prices printed on the face of the tickets. Fill in Columns G and H only if the person who bought the tickets is a reseller.

This report is due by the 10th day of each month and covers the gross receipts received during the previous month.
