A) North Carolina counties and cities receive a quarterly distribution of one fourth of a maximum of \$ 25,000 (depending on availability) for each qualifying Public, Educational, or Governmental (PEG) channel they operate [G.S. 105-164.44(b)]. A qualifying PEG channel is one that meets the programming requirements under G.S. 66-357(d). A county or city must certify to the Secretary by July 15 of each year the number of qualifying PEG channels it operates. A county or city may not receive PEG channel support for more than three qualifying PEG channels. The money distributed to a county or city for PEG channel support must be used by it for operation and support of PEG channels. The term "PEG channel" means "A public, educational, or governmental access channel provided to a county or city." [G.S. 66-350]

B) North Carolina counties and cities receive a quarterly distribution of their proportional share of each of the following three taxes, minus Supplemental PEG Channel Support, to replace local cable television franchise taxes repealed as of January 1, 2007 [G.S. 105-164.44F(a) and G.S. 105-164.44I(a)(b)]:

- 1) 7.7% of the net proceeds of the State Sales Tax on Telecommunication Services
- 2) 23.6% of the net proceeds of the State Sales Tax on Video Programming Services, other than Direct-To-Home Satellite Service
- 3) 37.1% of the net proceeds of the State Sales Tax on Direct-To-Home Satellite Service

A county's or city's proportional share is based on its certified amount of revenue from cable franchise fees and PEG channel subscriber fees for the first six months of Fiscal Year 2006-2007 compared to the statewide total of those revenues. The proportionate share for counties and cities that had no cable revenues during this time is based upon an amount equal to \$ 2.00 per capita [G.S. 105-164.44I(c)]. Proportional shares are adjusted each fiscal year by changes in certified populations estimated by the State Budget Officer [G.S. 105-164.44I(d)]. For purposes of this distribution, the population of a county is the population of its unincorporated areas plus the population of any ineligible cities in the county [G.S. 105-164.44I(g)].

C) Due to an error on the distribution for the quarter ending September 30, 2007 which was paid on December 17, 2007, some municipalities and counties received an incorrect amount for the PEG Channel distribution. Adjustments were made this quarter to correct the error and recover money from entities that received money in error and distribute money to entities that should have received PEG Channel money. For the entities that received the money in error, there will be a negative adjustment of \$ 1,840.49 per channel received in the Supplemental PEG Channel Support column above. This will reduce the entities' overall distribution for this quarter by this amount. If an entity was entitled to receive PEG Channel money last quarter but did not receive the distribution, there will be an adjustment of \$ 1,853.97 per PEG Channel in the Supplemental PEG Channel Support column above. This total is comprised of the \$ 1,840.49 per channel that was distributed last quarter plus an additional \$ 13.48 for two channels because we were notified by entities after the distribution that a PEG Channel included in the count was certified in error by the entities. This column will also include an amount equal to \$ 1,805.05 per channel that has been certified for this quarter.
